#### ★ RESERVATION FEE

The cost to reserve the Brazos Room or the Northside Room is \$100. This fee is non-refundable and cannot be applied to food/beverage costs.

We can reserve tables for parties up to 40 in our Southside area or Northside room - no fee applicable.

#### ★ FOOD & BEVERAGE

For private dining, all guests will be served in the standard serve line offered in the restaurant with the option of (1) the host paying the entire tab or (2) all guests paying individually.

#### ★ MENU & GUEST COUNT

The Brazos Room can accommodate 50 guests and the Northside Room can accommodate 75 guests. Menu options can be found on the attached page. Menu prices are subject to change without notice.

#### ★ DECORATIONS & DESSERT

Decorations must be pre-approved with management prior to the event date. No confetti, streamers, confetti balloons or candles allowed. Guests are welcome to bring in celebration cake of their choice. We recommend you bring your own cutting utensils and dessert plates.

#### ★ SERVICE TIME

All events are allotted a two (2) to three (3) hour time slot. Additional time can be discussed with management with the possibility of an additional cost. A 30 minute set up time is allotted prior to the reservation for decorating. Notice: during this time Big Horn BBQ employees will also be working to prepare the space for the event. All guests must be out of the room one hour before closing.

#### ★ ALCOHOL

Alcoholic beverages are prohibited to be brought on to Big Horn BBQ property. Big Horn BBQ reserves the right to slow or discontinue the service of alcohol in order to control consumption. Big Horn BBQ is required to follow TABC rules and regulations. All guests consuming alcohol must be at least 21 years of age with a valid ID.

#### ★ USE OF MEDIA

The use of the media center is offered to guests reserving the room. Any equipment brought in must be pre-approved by management. Big Horn BBQ is not responsible for any equipment brought into or left in the room. We recommend that you bring your media equipment in ahead of the reservation date and test the connections.

## ★ PAYMENT TERMS

The reservation fee is due when finalizing the reservation. A reservation is not complete without a documented payment of this fee. The remaining balance of food/beverage is due at the conclusion of the event on the reservation date.

## ★ CANCELLATION

All cancellations are required in writing. The reservation fee is non-refundable, but can be applied to a future date if Big Horn BBQ is given a written cancellation notice within four (4) days prior to the initial reservation.
